## Consolidated Scrutinizer's report on remote e-voting and voting conducted at the AGM.

I , CS Bharat Rathore (ACS: 48426) proprietor of M/s Bharat Rathore & Associates, Company Secretaries, Kota The Board of Directors of Chambal Breweries and Distilleries Limited at its meeting held on , 30<sup>th</sup> May 2024, has appointed me as the scrutinizer for the remote e-voting process as well as to scrutinize the physical ballot forms to be received from the Shareholders at the venue of the AGM pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and in accordance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The management of the Company is responsible to ensure the compliance with the requirement of the Companies Act 2013 and Rules and circulars issued by MCA and SEBI relating to voting through remote E-Voting and voting at AGM on the resolutions contained in the notice of AGM. Our responsibility as a scrutinizer is restricted to make a scrutinizer's report of the votes cast "in favour" or "against" the resolutions in the agenda items as stated above based on the report generated from the e-voting platform provided by CDSL.

The Company has availed the E-Voting facility offered by Central Depository Services (India) Limited for conducting the e-voting by the Shareholders of the company. The Service Provider had set up electronic voting facility on their website <a href="www.evotingindia.com">www.evotingindia.com</a> The Company had uploaded all the items of the business to be transacted at the AGM on the website of the Company and also the Service Provider to facilitate their Shareholders to cast their vote through remote e-voting.

The Shareholders of the Company holding shares as on the "Cut -off" date of 23rd July 2024 were entitled to vote through E-Voting on the proposed resolutions as set out in the Notice of the Annual General Meeting. The E-Voting process started on Friday, 26th day of July 2024 at 9.00 A.M and ends on to Monday, 29th day of July 2024,

Adroit Corporate Services P Ltd is the Registrar and Share Transfer Agents (hereinafter referred to as "RTA") of the Company.

The internal cut-off date for the dispatch of the Notice of the AGM was 28th June 2024 and as on that date, there were 6456 shareholders of the Company. The Company had sent the Notices of the AGM along with Annual Report and E-Voting details by e-mail to 4569 shareholders whose e-mail IDs were made available

by the two Depositories and for those shareholders, holding shares in demat and physical form, who had not registered their email IDs with the RTA. In respect of 1887 shareholders, notices were sent by courier.

The Company completed the dispatch of the notices to the Shareholders by Thursday, 4th July 2024.

As prescribed in clause (v) of sub rule 4 of Rule 20 of The Companies (Management and Administration) Rules, 2014, the Company also released an advertisement, which was published more than 21 days before the date of the AGM in "The Indian Express" English newspaper in English language and in "Rashtradoot" Vernacular newspaper in Vernacular language on 5th July 2024. The notice published in the newspaper carried the required information as specified in Sub Rule 4(v) (a) to (h) of the said Rule 20.

At the venue of the AGM of the Company, the facility to vote through ballot paper was provided to facilitate those Shareholders present in the meeting but could not participate in the Remote e-voting to record their votes. There were no votes cast at the venue of the AGM through ballot paper.

As per the information provided by the company, the names of the shareholders who had voted by remote e-voting through the facility provided by CDSL had been blocked and only those members who were present at the AGM and who had not voted on remote e-voting were allowed to cast their votes through ballot paper during the AGM.

After closure of e-voting at the AGM, the votes cast through remote e-voting prior to the date of AGM and through voting at the AGM were unblocked and downloaded from the e-voting system of Central Depository Services (India) Limited (CDSL).

The votes cast through remote e-voting were unblocked by me as a Scrutinizer in the presence of witnesses who are not in the employment of the Company as prescribed in Sub Rule 4(xii) of the said Rule 20.

I have scrutinized and reviewed the voting through remote e-voting and e-voting at the AGM and votes tendered therein based on the data downloaded from the e-voting system of CDSL.
