Consolidated Scrutinizer's report on remote e-voting and voting conducted at the AGM.

I, CS Bharat Rathore (ACS: 48426) proprietor of M/s Bharat Rathore & Associates, Company Secretaries, Kota The Board of Directors of Chambal Breweries and Distilleries Limited at its meeting held on 26th July 2025, has appointed me as the scrutinizer for the remote e-voting process as well as to scrutinize the physical ballot forms to be received from the Shareholders at the venue of the AGM pursuant to Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and in accordance with Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The management of the Company is responsible to ensure the compliance with the requirement of the Companies Act 2013 and Rules and circulars issued by MCA and SEBI relating to voting through remote E-Voting and voting at AGM on the resolutions contained in the notice of AGM. Our responsibility as a scrutinizer is restricted to make a scrutinizer's report of the votes cast "in favour" or "against" the resolutions in the agenda items as stated above based on the report generated from the e-voting platform provided by CDSL.

The original AGM scheduled on 20th September 2025 could not be held due to non-availability of quorum and was adjourned to 27th September 2025.

The Company has availed the E-Voting facility offered by Central Depository Services (India) Limited for conducting the e-voting by the Shareholders of the company. The Service Provider had set up electronic voting facility on their website www.evotingindia.com. The Company had uploaded all the items of the business to be transacted at the AGM on the website of the Company and also the Service Provider to facilitate their Shareholders to cast their vote through remote e-voting.

The Shareholders of the Company holding shares as on the "Cut -off" date of 13th September 2025 were entitled to vote through E-Voting on the proposed resolutions as set out in the Notice of the Annual General Meeting.

The E-Voting process started on Tuesday, 16th day of September 2025 at 9.00 A.M. and ends on Friday, 19th day of September 2025 at 5.00 P.M..

Adroit Corporate Services P Ltd is the Registrar and Share Transfer Agents (hereinafter referred to as "RTA") of the Company.

The internal cut-off date for the dispatch of the Notice of the AGM was 15th August 2025 and as on that date, there were 6002 shareholders of the Company. The Company had sent the Notices of the AGM along with Annual Report and E-Voting details by e-mail to 4148 shareholders whose e-mail IDs were made available by the two Depositories and for those shareholders, holding shares in demat and physical form, who had not registered their email IDs with the RTA. In respect of 1854 shareholders, notices were sent by courier.

The Company completed the dispatch of the notices to the Shareholders by Wednesday, 20th August 2025.

As prescribed in clause (v) of sub rule 4 of Rule 20 of The Companies (Management and Administration) Rules, 2014, the Company also released an advertisement, which was published more than 21 days before the date of the AGM in "The Indian Express" English newspaper in English language and in "Rashtradoot" Vernacular newspaper in Vernacular language on 21st August 2025. The notice published in the newspaper carried the required information as specified in Sub Rule 4(v) (a) to (h) of the said Rule 20.

At the venue of the AGM of the Company, the facility to vote through ballot paper was provided to facilitate those Shareholders present in the meeting but could not participate in the Remote e-voting to record their votes. There were no votes cast at the venue of the AGM through ballot paper.

As per the information provided by the company, the names of the shareholders who had voted by remote e-voting through the facility provided by CDSL had been blocked and only those members who were present at the AGM and who had not voted on remote e-voting were allowed to cast their votes through ballot paper during the AGM.

After the conclusion of voting at the adjourned Annual General Meeting, the votes cast through remote evoting prior to the original date of the AGM and the votes cast through ballot voting at the adjourned AGM were unblocked in the presence of two witnesses.
